Re: Tender No. CTN 399/2018 (1) – Supply of General Paints for Whole of Government

The Government Tender Board in its Meeting No. 61/2019 held on 14/08/2019 approved the Supply of Paints for Whole of Government to Resene Pacific Pte Ltd, Pacific Coating Ltd, Vinod Patel Co. Ltd for a period of **two (2) years** on “as and when required” basis.

The award is on option basis, hence Ministries & Departments must purchase from Option 1 supplier first. In an event where option 1 supplier is unable to supply, Ministries & Departments can move on to option 2 and so on provided that proper documentation is recorded for reasons for using other options.

The contract is effective from **11th September 2019** and will expire on **10th September 2021**. Detailed rates of individual items are attached as **Appendix 1**.

Ministries & Departments should engage the approved supplier on “as and when” required basis by issuing a purchase order. Officers are reminded of Section 35 of the Procurement Regulations 2010 where they are obliged to procure from the approved Government Contractors.

Ministries & Departments are required to plan their ordering and place orders in advance to allow the supplier to prepare collective orders and to ensure that payments of such purchase is made within 30 days of receipt of goods.

Officers who are involved in the procurement for their respective agencies are required to maintain a detailed record and monitor the performance of the supplier(s) during the contract period. Any complaints regarding the supplier(s) must be officially corresponded to the Head of Procurement, Fiji Procurement Office or submitted through the feedback portal on www.fpo.gov.fj

Kindly bring the contents of this letter to the attention of all officers involved in procurement and facilitation of payments for the above-mentioned contract.
