Re: **Tender No. CTN 21/2019 – Supply of Roofing Products Items for Whole of Government**

The Government Tender Board in its flying minute No. 52/2019 held on 09/08/2019 approved the Supply of Roofing Products Items for Whole of Government to various companies for a period of **two (2) year** on “as and when required” basis.

The award is on option basis, hence Ministries & Departments must purchase from Option 1 supplier. In an event where option 1 supplier is unable to supply, Ministries & Department’s to justify for opting second option. The contract is effective from **24<sup>th</sup> November 2019** and will expire on **25<sup>th</sup> November, 2021**. Detailed rates of individual items can be obtained from the undersigned officer.

Ministries & Departments should engage the approved supplier on “as and when” required basis by issuing a purchase order. Officers are reminded of Section 35 of the Procurement Regulations 2010 where they are obliged to procure from the approved Government Contractors.

Ministries & Departments are required to plan their ordering and place orders in advance to allow the supplier to prepare collective orders and to ensure that payments of such purchase is made within 30 days of receipt of goods.

Officers who are involved in the procurement for their respective agencies are required to maintain a detailed record and monitor the performance of the supplier(s) during the contract period. Any complaints regarding the supplier(s) must be officially corresponded to the Head of Procurement (Fiji Procurement Office) or call our feedback team on 3221234.


